



## **CYCLE WITH A COP** **RELEASE AND INDEMNITY AGREEMENT**

### CITY OF LAKEWOOD

Anyone wishing to participate in Cycle with a Cop (“Event”) must read and sign this Release and Indemnity Agreement (“Agreement”).

WHEREAS, the undersigned participant has voluntarily elected to participate in Cycle with a Cop at their own risk and understands that there are inherent risks associated with riding a bike on city streets; and

WHEREAS, the City believes that it can be beneficial to participate in bicycle education events; therefore

In consideration of the value of the educational opportunity to participate in this Event, and other good and valuable consideration, the undersigned participant, for himself or herself, his or her spouse, heirs, executors, administrators and personal representatives, does hereby:

- (a) Assume full responsibility during the Event for any personal injury or damage to the participant, or damage to the participant's personal property which may occur, directly or indirectly, while participating in the Event; and
- (b) Fully and forever release and discharge the City, its agents, volunteers and employees, from any and all claims, demands, damages, rights of action, or causes of action, present or future, whether the same be known, anticipated or unanticipated, resulting from or arising out of participation in the Event; and
- (c) Indemnify and hold harmless the City, its agents and employees, from any and all claims, demands, damages, rights of action, or causes of action, present or future, whether the same be known, anticipated or unanticipated, resulting from or arising out of any acts, omissions or conduct of the participant of whatever kind or nature whatsoever, during the Event; and
- (d) Agree to defend and to pay any costs or attorney's fees as a result of any action brought by or against the City, its agents, volunteers and employees, resulting from or arising out of any acts, omissions or conduct of the participant while the participant is participating in the Event; and
- (e) Represent that the participant is as of the date of execution hereof, of the age of eighteen years or has consent from their parent or guardian; and
- (f) Agree that it is the intent of the undersigned participant that this Release and Indemnity

Agreement be in full force and effect at any time after the execution thereof.
