**HUD Consolidated Planning Process**  
**Public Hearing #2**

**Background**

Every five years the City of Lakewood prepares a Consolidated Plan as a condition of receiving federal Community Development Block Grant (CDBG), Emergency Solutions Grant (ESG), and HOME Investment Partnerships Program (HOME) funding from the U.S. Department of Housing & Urban Development (HUD.) The Five-Year Consolidated Plan is carried out via (5) One-Year Action Plans which serve as the City's annual funding applications to HUD.

Based on a thorough analysis of market conditions and available resources, the Consolidated and Action plans identify and prioritize community and economic development needs; describe the strategies, activities, and resources that will be utilized to address high-priority housing, human services, infrastructure, neighborhood revitalization, and homelessness needs; and establish accomplishment goals and objectives in these areas.

**Public Hearing #1**

Lakewood held the first of two (2) public hearings during the City's Consolidated Planning process on Tuesday, June 3, 2025 at 6:00pm in the Lakewood City Hall Auditorium during which the City's federal funding sources and programs were reviewed; the Consolidated Planning process and timeline were discussed; and citizen input regarding the City's housing, community and economic development, and human services needs was solicited.

**Public Comment Period**

Draft versions of Lakewood's FY25-FY29 Consolidated Plan and FY25 Annual Action Plan have been issued for public review and comment for 30 days from Monday, June 9, 2025 to Tuesday, July 8, 2025.
