Re: Council Budget Priorities

Dear Colleagues,

Attached to this communication is a summary of the twenty-five Council Budget Priority Worksheet drafts submitted following Council's retreat on May 11th. Priorities address a wide range of topics, some which build upon existing investments, whereas others offer brand new ideas. Some priorities include an estimated budget, and others are more policy focused and budget neutral.

Some of these priorities were developed by councilmembers individually, some in small groups of no more than three councilmembers, and some in collaboration with staff or community stakeholders. The goal of identifying and announcing Council's priorities early is to ensure that Council and the Administration have ample time to collaborate prior to the introduction of the City's 2027 budget.

As the next step in this process, I propose that this communication be referred to Committee where the priority drafts can be discussed in greater detail, the Administration can better understand their impact on the City's 2027 budget, and the public may provide input.

In preparation for that discussion, councilmembers are encouraged to continue researching their priorities, speaking with appropriate staff and external stakeholders, and refining budget estimates. I expect that the drafts may be revised and refined based on the public discourse and continued research, and that final versions will be completed in time so that they may be included in the proposed 2027 budget when it is introduced this fall. It is my hope that this process will allow for a smooth and collaborative budget season.

<p>Large Tree Preservation</p> <p>The idea is to set up a framework whereby large trees are afforded some protections on the basis that a large tree on a property provides benefits beyond property lines and that Lakewood values its urban tree canopy. Pulling from other peer cities, this priority seeks to set up a system whereby in order to take down trees of a certain size on private property, a permit would need to be granted by the City. There would be exceptions for dangerous trees that pose imminent harm to public safety.</p>	?	Policy	Member						
<p>Speed Enforcement in School Zones</p> <p>Recent data shows that speeding in school zones during school hours is quite common. While Lakewood Police have done a tremendous job in ramping up speed enforcement (particularly in school zones), the behavior persists as police can only stop one person at a time. <p>Traffic Calming Review & Enhancement</p> <p>Review the current Traffic Calming Program, determine original goals and progress, and evaluate changes (if necessary). Even evaluate whether Traffic Calming Program should be codified into the Lakewood Codified Ordinances. Consider lowering thresholds based upon neighborhood support. <p>Youth Athletics</p> <p>I am currently coordinating with members of the Lakewood City School Board to explore the potential of splitting funding to the Lakewood Athletic Boosters (501(c)(3) non-profit organization) ("LAB") to hire an Executive Director to help support all competitive youth sports in Lakewood. The idea is for the City and the School Board to enter into a services agreement with the LAB whereby the LAB hires an Executive Director with the funding. <p>Affordability & Property Tax Relief</p> <p>The global affordability crisis impacts Lakewood residents in a variety of ways. Notably, some residents -- including fixed-income seniors and low-income homeowners -- are feeling financial strain due to higher property taxes, as property values in Cuyahoga County jumped an average of 32% following the 2024 reappraisal. <p>Safer Streets, Together Campaign</p> <p>Safer Streets, Together' (working title) is a 90-day public education campaign aimed at spreading awareness regarding the shared responsibility of motorists, cyclists/scooter riders and pedestrians in ensuring our streets are safe for everyone. This campaign seeks to support our complete streets initiative by promoting small safety actions as part of a cultural shift. A key element will be action-oriented messaging that discourages high-risk behaviors and encourages safe behaviors.</p>		Policy		Member					Member
<p>Styrofoam Recycling</p> <p>Styrofoam serves as a major detriment to our environment, with an estimated 2.3 million tons ending up in landfills nationally each year. This initiative calls for partnering with local business Edgewater Surf to establish drop-off recycling of EPS foam at the Lakewood Recycling Center. Edgewater Surf densifies EPS foam, using a small amount to make surfboards, and shipping the rest of the processed material to a partner company (Soprema Inc.) to be converted into new foam insulation.</p>	5,000	Budget & Policy		Member			Member		Member
<p>Ward 4 Voter Turnout/Community Engagement</p> <p>Ward 4 has historically lagged behind the rest of Lakewood in voter turnout, and the recent primary election proved no exception. During the election held on May 5, roughly 18% of registered voters in Ward 4 voted compared to nearly 30% citywide. This initiative seeks to formulate a comprehensive, non-partisan plan, consisting of both short-term and long-term strategies, to reduce this gap and improve voter turnout within Ward 4.</p>	? Explore management and financial model in which Lakewood City Schools would contract with the City to provide staffing for a portion of these positions (to be decided), helping to overcome personnel bottlenecks. Expanded Parks Bathroom Access Expand Parks bathroom access beyond current practices.
