Chad Fedorovich and Derek Brennan presented their preliminary concept for the wall at 13359 Madison Avenue. They noted they are going to do an event where people walking their dogs could get their photos taken for potential inclusion in the mural. They noted the materials they plan to use and that they have a 10-15 year life span. The Board approved of the direction of the artwork.

Arlin Graff was presented his preliminary concept for the Birds of Birdtown. He discussed the fabrication and installation method. The Board discussed possible ways to program the artwork. The Board then approved of the direction of the artwork.

**7. Mural Proposal: Hilliard/Madison**

Aaron Casey presented a preliminary concept for the wall along Sunoco on Madison Avenue. The Board was concerned about the two pieces being very different and wanting to see them in Mr. Casey’s style as opposed to ChatGPT. Both sides of mural need more cohesion. Mr. Casey will send an updated design for review at the next meeting.

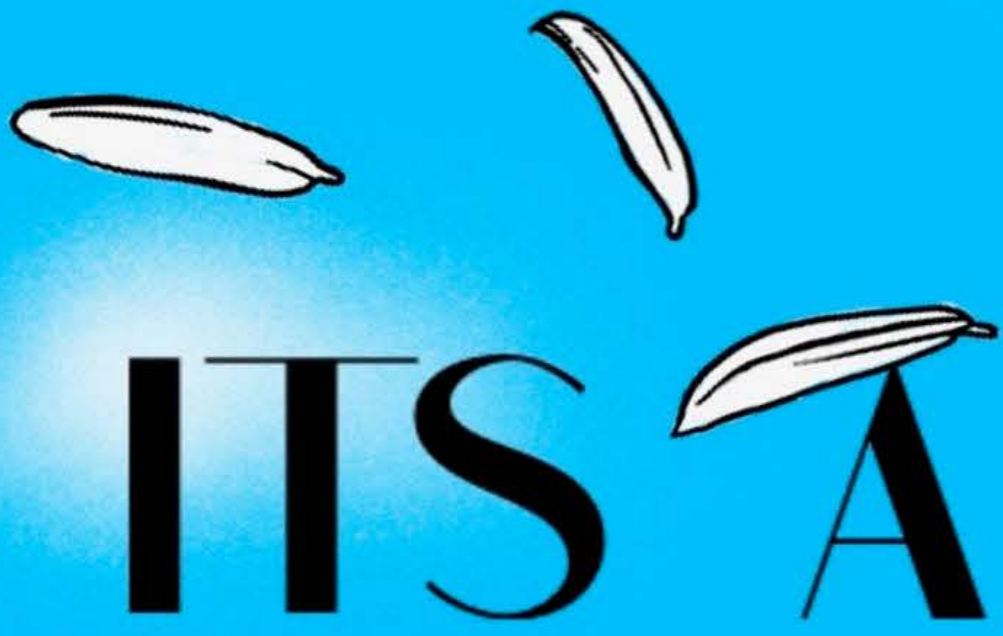
